

Speaking to members of the media during a media briefing at the Border Post, Commissioner Boshoff indicated that the PSC will use the inspection to engage stakeholders based at the Border Post to get response from the Department of Home Affairs and other stakeholders on how to address the challenges.

He further concluded that the Commission will compile a report with recommendations and it will be presented to the members of Free State Provincial Legislature for remedial actions.

PSC COMMEMORATES 16 DAYS OF ACTIVISM FOR NO VIOLENCE AGAINST WOMEN AND CHILDREN

South Africa will as from 25 November to 10 December 2015 celebrate the 16 Days of Activism for no Violence Against Women and Children. It is a time to galvanise action to end violence against women and girls around the world. The international campaign originated from the first Women's Global Leadership Institute coordinated by the Center for Women's Global Leadership in 1991.

The year 2015 marks the 20-year anniversary of the Beijing Declaration and Platform for Action, the most progressive road map to gender equality. World leaders met in March at the United Nations 59th Commission on the Status of Women and in September at the 70th General Assembly to take stock of the progress made and commit to take action to close the gaps that are holding women and girls back. This year a new Sustainable Development agenda, which for the first time includes specific targets and indicators on ending violence against women, also replaced the Millennium Development Goals.

The United Nations Women Executive Director Phumzile Mlambo-Ngcuka said during the International Day for the Elimination of Violence against Women "if we all work together: governments, civil society organisations, the UN system, businesses, schools, and individuals mobilising through new solidarity movements, we will eventually achieve a more equal world a Planet 50/ 50 where women and girls can and will live free from violence. ACCEPTANCE OF GIFTS

As we are preparing for the Festive Season, setting up shiny lights, unwrapping ornaments, buying presents and arranging to spend time with family and friends, it's a good time to reflect on a kind of gift giving that can be problematic: gifts from existing and potential service providers of the OPSC. This is an issue year-round, but during the holiday season the pressure is even greater to accept the well-meaning box of chocolates or biscuits, vouchers, discounted rates on accommodation or the like.

The OPSC has rules regulating the acceptance and disclosure of gifts, as well as a Gift Register. Employees are reminded that if any gift was received, it should be recorded in the Gift Register, available in the Offices of the DDG: CS and Provincial Directors.

Code of Conduct for the Public Service

Employees should not use her or his official position to obtain private benefits for herself or himself during the performance of her or his official duties nor does she or he accept any gifts or benefits when offered as these may be construed as bribes.

Financial Disclosure Framework for Members of the SMS To declare gifts and hospitality from a source other than a family member with a value in excess of R350 and well as hospitality intended as a gift in kind.

Employees to obtain prior written approval from the DG to obtain or accept gifts, benefits or items of monetary value (in excess of R350).
