DEPUTY CHAIRPERSON'S INFORMATION SESSION

Finally, the National Office of the PSC took occupancy of ABSA Tower on Monday, 20 July 2015. Although it has taken a while largely because the building was not ready for occupation, the historic move from Commission House to ABSA Towers finally took place. The Branch: Corporate Services was the first to relocate on Friday, 17 July 2015 followed by line function branches.

In an attempt to make everyone every feel at home, the Deputy Chairperson convened an Information Session on Monday, 20 July 2015 to officially welcome Team PSC at ABSA Towers. Besides the officials, the Information Session was graced by Commissioners as well as Reverend Stimela and Raphahlela who opened the session with prayer. In welcoming the Deputy Chairperson, the Acting Director-General, Dr Dovhani Mamphiswana congratulated the relocation committee under the leadership of the Deputy Director-General: Corporate Services for trying their level best in ensuring that the transition from Commission House to ABSA Towers was seamless. He appealed to members of Team PSC to be patient during this transition period.

Dr Mamphiswana acknowledged the concerns that had been raised by officials regarding the outstanding work that needed to be done by contractors, such as cleaning of carpets, electricity connection etc, and promised that PSC's concerns have been brought to the attention of the landlord and will be attended to.

In his address, the Deputy Chairperson mentioned that he was aware of the challenges that had been raised and urged everyone to work together to ensure that they are overcome. He also mentioned that although our stay at ABSA Towers is a temporary one, he would like to encourage everyone to feel comfortable in our temporary home. The Deputy Chairperson also indicated that the Commission has made it clear to the Department of Public Works to ensure that the Public Service Commission has a permanent home long before the expiry of the current lease at ABSA Towers. We hope that within 18 months we will relocate to our permanent home which should be in the Pretoria precinct. We will keep everyone abreast of any developments as we go along. He further encouraged everyone to commit themselves to upholding the integrity of the Commission.

SECURITY AT ABSA TOWERS

The Sub-Directorate: Security Services is responsible for the safety of all members of Team PSC at ABSA Towers. In order to ensure that officials' safety is not compromised, officials should take note of the following security measures applicable at ABSA Towers:

Access control to the parking area

The National Office of the PSC has been allocated 150 parking bays. The Executive parking area is clearly marked. Officials are requested to park only at the areas allocated to the PSC. A lost access card will be replaced at the official's own cost for R100. It is the responsibility of everyone to inform the Security personnel in advance regarding visitors and the time of arrival to allow enough time to make for the necessary parking arrangements.

Introduction of Biometric Access System to the PSC

All officials will be enrolled in the system to gain access to the Office. The visitors who will be staying for longer periods at ABSA Towers will be temporarily enrolled in the system for the duration of their stay.

Cable lock for Laptops

All officials are requested to ensure that their laptops are secured with a laptop cable lock. In the case of theft, the affected official will the held responsible for the full cost of the replacement of his/her laptop if it was not properly secured with a cable lock.

Confidential/secret documents

All official must ensure that all classified documents are locked in cabinets before they leave their respective offices.

Valuables

All officials must ensure that extra care is taken for their valuables in light of the open plan working environment.

Respect for colleagues' space

Given the open plan environment, radio should not be played loud. Also, all officials are requested to lower their voices when communicating with each other.

The office also provided the shelter with 79 food containers, plastic eating utensils, and cups, chopping boards, cutting knives, peelers and serving spoons. The Western Cape weather had been very cold and the provincial offices further donated tea, sugar and powdered milk.

Lastly, as part of its role in the Institution Supporting Democracy Forum within Limpopo, the provincial office will through workshops, engage all the employees in the Chapter 9 institutions on the code of conduct, Remuneration Work Outside the Public Service (RWOPS) and grievance management.

In an effort to provide strategic direction to the Office, the Commission held its Strategic Planning Session from 14-16 July 2015 at the Environmental House in Pretoria under the theme: "Enhancing the Role and Impact of the PSC in Building a Capable and Developmental State". Chief Justice Ngcobo made an input on the work of the Presidential Review Commission whilst, Adv Dumisa Ntshebeze made a presentation on effective and efficient conflict management in the Public Service. The Strategic Planning Session addressed some of the following issues:

- Reflected on and created a shared understanding of the PSC's holistic mandate (Constitutional/Legislative and Assigned).
- Created synergy between the work streams of the PSC with the Constitutional mandate.

- Developed strategies and identified initiatives to take forward the proposals made in the Developmental State discussion document.
- Identified and generated key projects for the 2016/17-2018/19 financial years.
- Reviewed the first year performance of the implementation of the PSC's strategic plan.
- Conducted a review of policy changes that might have an impact on the work of the PSC.

Ably facilitated by K Sedibe and S Sithole from PRASA, the strategic planning session was as success. The Commission hopes that the guidance received at the Strategic Planning Session will enable the Office to compile the PSC's workplan for 2016/17 aligned to the Budget and the Annual Performance Plan.
