PSC - CELEBRATING 100 YEARS OF EXISTENCE

The Public Service Commission (PSC) kicked off its 100 years celebrations in a form of stakeholder engagement on Friday, 24 May 2013 at the Crowne Plaza Hotel (Rosebank) in Gauteng. Organised under the theme: Celebrating 100 years of Public Service Evolution and Transformation, the stakeholder engagement, which was hosted by the Gauteng Provincial Office was attended by amongst others, PSC Commissioners, officials, representatives from Chapter 9 Institutions, civil society and members of the Gauteng Provincial Legislature including the MEC of Education, Ms Barbara Creecy and the Deputy Chairperson of Committees in Gauteng, Honourable Valentine Mbatha. The former Chairperson of the Gauteng Provincial Service Commission, Professor Patrick Fitzgerald was also in attendance and he shared with the audience some of his memories of the Gauteng Provincial Service Commission.

In his opening remarks, Commissioner Michael Seloane stressed that the primary aim of the stakeholder engagement is to profile and promote the work of the PSC, as well as reflect on its evolution and transformation in the Public Service.

Addressing the stakeholders, the Chairperson of the PSC, Mr Ben Mthembu mentioned that: "over the past 100 years the Commission has evolved from an instrument of control in an oppressive undemocratic state into an independent developmental agent of Public Service transformation and change under democracy".

In relation to the current state of the Public Service, Mr Mthembu raised a concern regarding the rise in the tender state and the emergence of tender-preneurship rather than the emergence of entrepreneurship. He further said: "evidence from the work conducted by the PSC suggests that despite pockets of excellence, service delivery performance is poor and in some cases getting worse". Improving the quality of service delivery, said Mr Mthembu, requires that a number of areas of public management must be addressed urgently (The Chairperson's keynote address can be accessed on the intranet)

Delivering a message of support, the Deputy Chairperson of Committees in Gauteng, Honourable Valentine Mbatha wished the PSC well in its centenary celebrations and in its execution of its constitutional mandate. He further mentioned that "public officials should make decisions and provides advice without regard for personal gains and that they should dispose of, or restricts the operation of, private financial interests, personal relationships or affiliations that could compromise official decisions in which they are involved".

As part of the centenary celebrations, the PSC will also host similar stakeholder engagements in the Eastern Cape (13 June 2013) , Mpumalanga (20 June 2013), which will culminate into a national conference and gala dinner in Cape Town (01 August 2013) . Plans are already afoot to organise an event in July 2013 for Team PSC to celebrate the Organisation's 100 years of existence.

MINISTER SISULU ACKNOWLEDGES THE WORK OF THE PSC

On 22 May 2013, Minister for Public Service and Administration, Lindiwe Sisulu delivered her Budget Vote Speech in the Old Assembly in Cape Town. During her speech, she mentioned that she was grateful that the Portfolio Committee on Public Service and Administration has been most supportive and understanding. Acknowledging the contribution made by various institutions falling under her Portfolio, the Minister said the following about the PSC: "The Public Service Commission has graciously complied with all

"The Public Service Commission has graciously complied with all the requests made of them, grinning and bearing it all, protesting their independence".

The Minister further mentioned that: "The Ministry for Public Service and Administration will partner with the Oppenheimer Memorial Trust in 'Developing, recognising and retaining [world-class] talent in the South African Public Service'. This partnership will see ten (10) public servants each being awarded a scholarship every year for opportunities to study abroad and locally to sharpen their competence".

A cursory reading of the reports of the AG and the PSC paints a dim picture of non-compliance, remarked the Minister. To remedy and to respond to this challenge in a focused way, she mentioned that her Ministry has established an Office of Standards and Compliance to address non-compliance.

She also promised to deal decisively with corruption in the Public Service by setting up an Anti-Corruption Bureau that will have legislative authority to investigate, intervene, and where necessary assist departments, provinces and local governments in dealing with cases of corruption related misconduct. "Pre-emptively the Bureau will deal with cases where processes and procedures have not been followed. If criminal conduct is detected the bureau will solicit the help of the anti-corruption agencies of the state to investigate and prosecute where necessary".

"We are aware that some public servants are manipulated by elements out there in the private sector. They have mastered the procurement system of government and have positioned themselves better to manipulate it from outside. We intend to deal with both very decisively. We want to ensure that there are minimum sentences for public servants found guilty of corruption. For the private sector, once we secure a conviction for corruption, a company will be blacklisted and barred from trading with government. I have already instructed my legal team to find ways to strengthen our fight against corruption in this way", stressed Minister.

The Minister also raised the same concern raised by the PSC about the late submission of financial disclosures by members of the senior management services (SMS). She revealed that "after the successful piloting of the e-disclosure system in three provinces, the MPSA is in a position to rollout e-disclosure to cover all designated public servants by June 2014. This will enable public servants to declare their financial interests electronically and activate a system-wide multiple checking against other systems".

In conclusion, the Minister mentioned that the total budget available for the MPSA Portfolio for the financial year 2013/14 is R816 371 000 (R816, 371 million). Of this amount, the PSC will receive R201, 1 million.

Every year, on 31 May, the world celebrates **World No Tobacco Day**, which highlights the health risks associated with tobacco use and advocating for effective policies to reduce tobacco consumption. Tobacco use is the single most preventable cause of death globally and is currently responsible for killing one in 10 adults worldwide. The theme for World No Tobacco Day 2013 is: **"ban tobacco advertising, promotion and sponsorship"**.

Evidence suggests that comprehensive advertising ban lead to reduction in the number of people starting and continuing smoking. Statistics show that banning tobacco advertising and sponsorship is one of the most cost-effective ways to reduce tobacco demand.

The global tobacco epidemic kills nearly 6 million people each year, of which more than 600 000 are non-smokers who die from breathing second-hand smoke. Unless we act, the epidemic will kill more than 8 million people every year by 2030.

Team PSC, remember to bacco contains nicotine, a highly addictive drug that you start to crave when you are without it. This is what makes it so difficult to give up. Your body and brain soon starts to need nicotine in order to feel good, resulting in addiction.



BOOK REVIEW




Title : Management principles: a contemporary edition for Africa

There are challenges presented by the fast-changing business environment which requires that organisations find new and innovative ways to respond in order to improve performance. The contemporary manager has to integrate new information technology, manage diversity, accommodate stakeholders' often conflicting claims, and deal with the threat that HIV/AIDS poses to the workplace.

This book (Management principles: a contemporary edition for Africa) deals with the latest challenges facing managers. It also exposes the reader to the traditional management functions, such as planning, organising, leading and controlling.

Abstract:

David Silverman's new edition of "Doing Qualitative Research" is a cutting-edge compendium of what students want to know about conducting and completing a qualitative study. His book sets a new standard for an inclusive student-friendly manual that cuts across disciplines and methods, while systematically unveiling ordinary research practice. Silverman includes sage advice gained through his many years of research and dissertation supervision. He offers insider tips, shortcuts, and warnings that will keep

students involved in their projects and guide them through each step of the process. Throughout the book, Silverman shares his students' stories of their research experience and the obstacles they encountered along the way. In short, "Doing Qualitative Research" is an accessible, engaging text that sparkles with ideas, insight, and information."

"Doing Qualitative Research, 3rd Edition" provides a step-by-step guide to all the questions students ask when beginning their first research project. Silverman demonstrates how to learn the craft of qualitative research by applying knowledge about different methods to actual data. He provides practical advice on key issues such as: defining originality and narrowing down a topic; keeping a research diary and writing a research report; and presenting research to different audiences. "Doing Qualitative Research, 3rd Edition", is substantially updated and revised. Among its new and attractive features are: a problem-based format, making extensive use of statements and queries by recent research students; as well as two new chapters on data-gathering and ethical issues in student research.
